The targeted wage subsidy program provides a subsidy to employers to hire an individual who has difficulty accessing employment due to special barriers and who would require on-the-job experience to become fully productive. Certain eligibility criteria must be met for both the employer and the employee. While negotiated on an individual basis, the duration of the wage subsidy typically lasts from six to eight months.
